A set of practical strategies and ideas aimed at reducing the public health risks associated with drug use.

Harm Reduction calls for the non-judgmental, non-coercive provision of services and resources to people who use drugs, and the communities in which they live, in order to assist them in reducing harm.


#### Harm Reduction asks

- Non-clinical, strengths-based support
- Different names or titles
   Peer specialists, peer recovery coaches, peer advocates, peer wellness specialists or peer recovery support specialists

### Harm Reduction Peers

- Allies who
  - Focus on client-identified priorities,
  - Hold unconditional positive regard,
  - Provide trustworthy information and compassionate feedback, and
  - Advocate for and link clients to services
- Amplify harm reduction by sharing their lived experience
  - Navigating services and systems,
  - Learning and making decisions about safer use, and
  - Personal healing and hope

## Issue Presentation & Discussion

When a peer-based harm reduction program first stands up, especially within a larger agency, like a community organization, substance use treatment program, health clinic or hospital, it can be a challenge for harm reduction peers to "find their way".

Integrate into multi-disciplinary teams; or

 Demonstrate the value the peer brings to their organization and team members?
