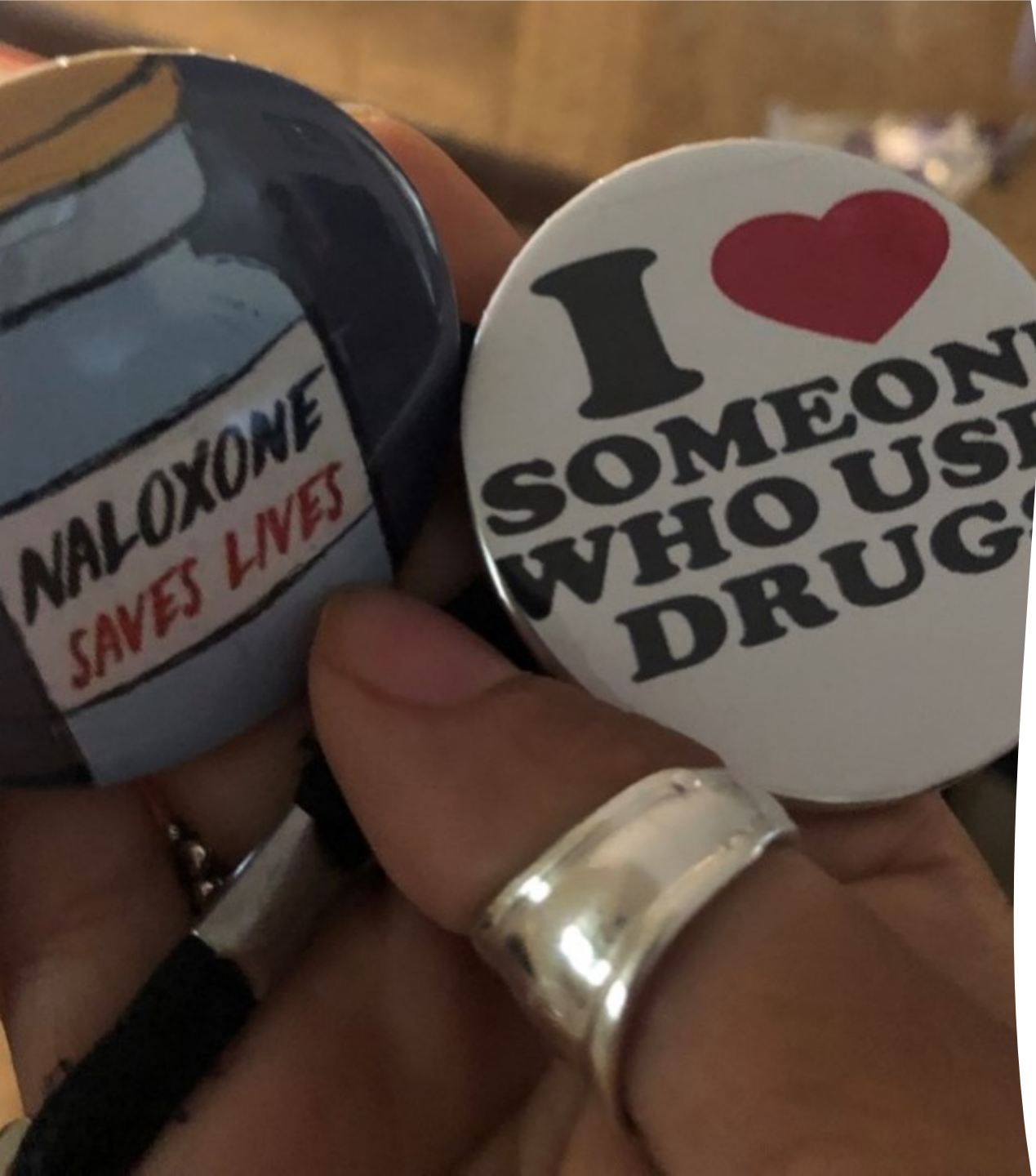



## Oregon Measure 110

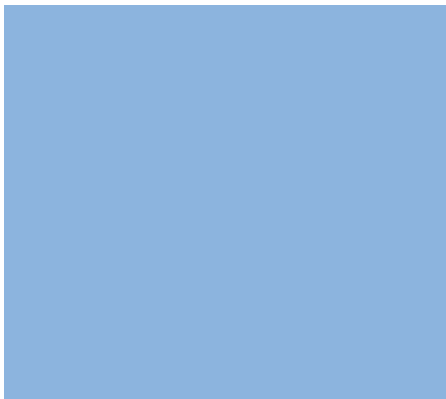
Result	Votes	Percentage
✔ Yes	<b>1,333,268</b>	58.46%
No	947,313	41.54%

# Measure 110 Oversight and Accountability Council

[Ballot Measure 110](#), the Drug Addiction Treatment and Recovery Act, requires the formation of a grant program to fund Addiction Recovery Centers and an Oversight and Accountability Council to determine how the grant funds will be distributed.

The council will also oversee the implementation of the centers.
