Description:

In this series of presentations moderated by Dr. Patricia (Tricia) Capo (Minnesota Chippewa Tribe), Indian Health Service (IHS) Deputy Chief Clinical Consultant for Obstetrics and Gynecology, welcomes speakers Dr. Michelle Debbink, assistant professor in the Department of Obstetrics and Gynecology at the University of Utah School of Medicine and Vice Chair for Equity, Diversity, and Inclusion in the Department of Obstetrics and Gynecology at the University of Utah Health Sciences Center, Andrea Klimas (Oglala Lakota), Clinical Director at Native American Connections Patina Wellness Center, and Danelle Trottier, MBA, Senior Director of Operations-Residential Treatment for Native American Connections. Dr. Michelle Debbink opens with a case discussion, and provides a broad overview of providing pregnancy care in the 1st, 2nd, and 3rd trimesters, best practice guidelines as well as special considerations, including substance use care. Then, Andrea and Danelle share the story of the Patina Wellness Center, a residential substance use treatment center designed to support pregnant people and families in recovery from addiction or substance use disorder and prevent family separation. The new Care and Access for Pregnant People ECHO Program includes an opportunity to engage in a didactic presentation, gain insight on how I/T/U facilities may effectively integrate timely pregnancy care, and become part of a learning community.
